Shared prompt:

Read the following introduction (adapted from philosopher Frederick Schauer's work). After that, you will make decisions about 4 simple cases and answer a few questions about it.

One day, a black dog called Angus ran, jumped around, barked and ate off the floor in a restaurant. Such case was thought to be the paradigm of something to be avoided in the future: behaviors that cause nuisances to costumers. Thus, the restaurant's owners created a rule: "no dogs in the restaurant".

Cat

A man enters the restaurant with his pet cat.

Did he break the rule? (Yes or No)?

Fish

A kid enters the restaurant carrying a goldfish inside a plastic bag filled with water, which was bought moments before at the pet shop near the restaurant.

Did he break the rule (Yes or No)?

Robot

A kid enters the restaurant with a cutting edge toy: an extremely realistic robot dog, identical to a real dog and who acts like a real dog: it barks, jumps, drools and walks on four paws.

Did he break the rule (Yes or No)?

Dead dog

A man enters the restaurant bringing a taxidermied dog, which he takes everywhere he goes as a way to keep close to his old buddy.

Did he break the rule (Yes or No)?

Pig

A man comes to the restaurant with what seems to be a pig. Actually, it's his dog dressed in an extremely realistic costume. We only realize that the man is accompanied by a dog - and not a pig - because he barks somewhat frequently

Did he break the rule (Yes or No)?

Teddy bear

A child enters the restaurant carrying a purse containing what seems to be a teddy bear. Actually, it's her dog, who doesn't bark and barely moves, being easily mistaken for a toy.

Did he break the rule (Yes or No)?

Misbehaving dog

A man enters the restaurant with a dog that runs, jumps, barks and eats food from the floor.

Did he break the rule (Yes or No)?

Seeing eye dog

A blind man arrives at the restaurant with his seeing eye dog, for which he holds documentation proving special training that ensures he won't cause nuisances to the other costumers in the restaurant.

A person enters the house wearing very clean shoes that she just bought, unboxed and put on at the house's entrance hall.

Underinclusion

A person enters the house barefoot, but with very dirty feet.

Off-topic

A person enters the house barefoot and with clean feet.

Did the person break the rule?

Did the person entered the house wearing shoes?

Did the person dirtied Mary's house?

No cars in the park

Rule

One day, at the local park, there was a tragic accident involving a pedestrian and a car. The park's administrator, attending to the seriousness of the situation and aiming to avoid accidents that can imperil parkgoers physical integrity, established that: "no cars are allowed inside the park".

Core

A person enters the park in his car.

Overinclusion

A kid enters the park and plays with his toy car.

Underinclusion

A person enters the park in his motorbike.

Off-topic

A person walks into the park.

Question

Did the person break the rule?

Did the person entered the park with a car?

Did the person increased the risk of an accident?

No sleeping in the station

Rule

A group of people slept at the benches of the train station every night. The train station administrator, weighting the seriousness of the situation and aiming to avoid that people would use the station benches as their homes, established that “no sleeping is allowed on the station’s benches”.

Core

A homeless person sleeps at the train station’s benches every night.

Overinclusion

A busy businessman is waiting for his train sitting on a bench at the station. However, he is very tired because of all the work he has done all day and falls asleep for about 5 minutes.

Underinclusion

A homeless person spends 12 hours a day sitting on a bench at the station, without, however, ever sleeping there.

Off-topic

A person enters the station and buys tickets for the next train.

Questions

Did the person break the rule?

Have the person slept in the station’s benches?

Did the person used the station as his home?

No smartphones in the classroom

Rule

Classes at a given school were frequently disrupted by students using their smartphones. The school's principal, aiming that students should pay attention to their classes, established that "no smartphones are allowed in the classroom".

Core

A student is texting in his smartphone instead of paying attention to his class.

Overinclusion

An assignment requires the use of a calculator and a student is using his smartphone calculator in order to complete the required assignment.

Underinclusion

A student is using his tablet to play videogames during class.

Off-topic

A student is paying close attention to class.

Questions

Did the student break the rule?

Was the student using a smartphone during class?

Was the student paying attention to his class?

Study 3

Religious minorities (legal)

Due to an increase in the persecution of religious minorities, the Department of Transportation budgeted for the installation of ecumenical chapels in all airports. Each chapel is clearly identified with a sign that reads “Members of all religious traditions are welcome to use this chapel to pray. Please, do not use this space for other purposes”.

James, who is from a predominantly catholic country, was harassed in the past for his agnosticism. He recently started reading “The Numerical Fabric of the Universe”, the biography of an atheist mathematician who won the Nobel prize. James is constantly interrupted and hindered in his reading by his religious colleagues. Thus, in between flights, James goes to the ecumenical chapel in order to peacefully read his book.

As José is in a high risk job, his contract includes a "zero tolerance" clause with respect to "the use of narcotics, including alcohol, marijuana and other recreational drugs." Traces of those substances might be considered breach of contract, causing the employee's firing. José ate a piece of chocolate pie the night before and is fired based on the alcohol found in the tests.

Meliss, a biology student, stores the peanut shells whenever she eats peanuts and throw them inside the tree beds in her street. Meliss knows that they will take approximately 5 weeks to decompose.

Insider trading (legal)

Alice was a director at the Shwarma pharmaceutical company for 20 years. One of the drugs manufactured by Shwarma was tyradozin, which was needed to treat a chronic disease. Tyradozin was sold by one of the companies of the Shwarma group, Tyradozol.

Near her retirement, Alice found out that Shwarma was planning to sell its stock in Tyradozol to a foreign subsidiary, aiming to unilaterally increase prices on tyradozin, generating millions of dollars in profit for the company's shareholders. After all, tyradozin consumers could not survive without the drug.

On the eve of the operation, Alice, already retired, asked her son's Marcos financial adviser: "Should Marcos buy some Tyradozol stock?". Her goal was to suggest that her son should buy a significant portion of the company, as she imagined her son would not take the immoral action of hiking tyradozin prices. Before the market closed, on that day, Marcos, after a meeting with his financial adviser, buys a majority stake on Tyradozol, frustrating Shwarma's investors plan.

The practice known as insider trading is forbidden by federal law: "Directors of companies with stocks negotiated in the stock exchange cannot use private information to transact". The law's goal is to stop executives from financially gaining from confidential information that they gather because of their jobs. Alice, a stark defender of the socialization of health costs, believes that she had a duty to fight against the unwarranted price hiking of medical drugs.

Felipe uses the voice-to-text functionality of his smartphone to text his friends, while doing that, he suffers a grave accident involving another vehicle. The occupants of both cars get hurt.

The confederate watched the clients and warned the rest of the gang when someone withdrew a large enough sum. This client was then robbed and the profits were shared among the gang members.

Danilo, despite knowing about the recent bill, exchange messages with his girlfriend on whatsapp while waiting to speak with his manager.

Aiming to avoid this kind of fraud, and to facilitate the identification of criminals, the bank created a general rule forbidding all clients from entering branches while wearing hats.

João enters the bank wearing sunglasses and a bandana on his head. He cashes in a fraudulent check over the counter and no one is able to identify him afterwards based on security camera footage.

Maria, the cashier, noticing how upset Juliana was and knowing her and her age, allows the purchase to go through without the presentation of photo ID.

Moved by adrenaline, he doesn't notice other cars on the lane driving slower than usual to respect the new speed limit. Rafael's conduct causes an accident involving 2 other cars and leaving 3 people gravely injured.

No objects at the fair (non-legal)

Many people preferred to carry small handbags to store money and documents and, sometimes, they left them unattended at the table while they distractedly ate. Because of this, the organizers decided to edit the event's regulations, adding the provision that all costumers, upon arrival, should store all their belongings in a security box provided and secured by the fair. Visitors should keep only essential items (money, credit card and ID) on their pockets. A sign advertising the change was placed at the fair's entrance, and there were also employees letting visitors know about the rule.

On that year edition, a couple of blind people, Gabriel and Geisa, went to the fair with their canes. No one asked them to head towards the security box.

One day, Gaia, a 24 year old young woman, hears about the nightclub from her friends, and, excited with the idea promoted by them, decides to take her pet Boa Constrictor snake Melaine to the club. Once inside the nightclub, however, Melaine terrorizes the other costumers and animals, making many of them leave out of fear that the snake could escape her leash.

Driving license (legal)

National law prohibits people from driving without a driver's license, a document issued by the government after the applicant passes a driving test and that needs to be periodically renewed so that the fitness for driving is confirmed. This way, it is possible to prevent people who don't know how to drive from driving and who, for that reason, could cause accidents.

Pedro, who holds a government issued license after being approved in a driving exam, but whose license is already expired, and knows how to drive with great skill, drives a car.
