Definitions: Events

- Future event is any event in the document that describes a future situation.
- Forecast statement is any text in the document that refers to a possible future event
- *Current event* is any event <u>in the document</u> that describes a current situation.
- **Current statement** is any text in the document that refers to a possible current event.
- Event statement is text that we write to clearly articulate the event that is described in the document.
- **Current event statement** is text that <u>we write</u> to clearly articulate the current event that is described in the document.
- Forecast event statement is text that we write to clearly articulate the future event that is described in the document.

Summary of Rules for Composing Current and Future Event Statements

- 1. Event statements should be created for all current and future events referenced in the document.
- 2. Event statements should, where possible, be self-contained.
- Event statements should be composed using the language that appears in the original text.
- 4. Event statements should state a specific time span even if the document is imprecise.
- 5. Event statements should be constructed as non-conditional and non-causal statements.
- 6. Event statements should simply assert that something is true or will be true. No probabilistic or transitional language should be included.
- 7. When rules conflict, use best judgment to resolve conflict.

Rule 1: Event statements should be created for all current and future events referenced in the document.

This paragraph refers to four events. These are parsed as two current and two future event statements.

Rule 2: Event statements should, where possible, be self-contained.

Each event statement can be read and understood without referring to other statements. This usually requires repeating phrases from the original text multiple times. In this case the phrase "Al-Qa'ida will pose the greatest threat" is repeated in both 1.3 and 1.4.

Rule 3: Event statements should be composed using the language that appears in the original text.

Although various parts of the original text may need to be compiled in new ways to create event statements, the language from the original text should be used to create event statements. Even if the original text is unclear, avoid introducing new words that potentially change the meaning of the original text. Leave it unclear. In this case, words and phrases such as "seriously damaged", disrupted the operations", "greatest threat", etc. may be hard to define with precision. They should still be included in the event statements.

Rule 4: Event statements should state a specific time span even if the document is imprecise.

If the original document provides forecasts for a specific time period, then state that time period in each event statement. If the document is not precise (e.g. "in the relatively near future") then assign a representative time period for that document.

Rule 5: Event statements should be constructed as non-conditional and non-causal statements

Here the document text refers to three distinct events where the first two events lead to (cause) the third event. In writing the event statement for the third event, the first two events should <u>not</u> be mentioned.

Rule 6: Event statements should simply assert that something is true or will be true. No probabilistic or transitional language should be included.

Text item 7 asserts that the movement "is becoming more diffuse," but the event statement simple states "will be more diffuse." Text item 8 asserts "increasingly likely to emerge," but the forecast event statement states "there will be."

Rule 7: When rules conflict, use best judgment to resolve conflict

Rule 5 says that event statements should not contain causal or conditional connections, so 34.1 and 34.2 do not mention the "loss of key leaders" from 33. But this violates Rule 2 which says event statements should be self-contained. 34.1 and 34.2 violate Rule 2 because the reference to "like-minded individuals" is senseless without referencing 33.

Definitions: Causal Connections

 Causal precursor – Event A is a causal precursor of event B when the document claims, in any way, that the occurrence of event A directly increases the chances that event B will occur.

 Causal connection – If event A is a causal precursor of event B then events A and B are causally connected.

Rule 8: For each event, list any events indicated in the document that are direct causal precursors.

Based on the reading of the original text, the phrase "If this trend continues, ..." implies that 3.1, 3.2, 3.3 and 3.4 are direct causes of events 4.1 and 4.2. In turn 4.1 and 4.2 are direct causes of 4.3.

Label event statements that are hypothetical events

Definitions: Definitional connected

 Definitional precursor – Event A is a definition precursor of event B when event B is only meaningful if event A occurred.

 Definitional connection – If event A is a definition precursor of event B, then events A and B are definitional connected

Rule 9: For each event, list any events indicated in the document that are direct definitional precursors.

A definitional precursor simply means that the event statement doesn't make sense unless you look at the precursor event statement. In this case 34.1 and 34.2 refer to "like-minded individuals", which is meaningless unless you know the information in 33.1.

Definitional precursors are rare. Deal with them in two steps. First, state the forecast event as specified in the text, as was done for 34.1 and 34.2. Second, rewrite them consistent with Rule 2 (event statements should be self-contained). So, statement 3.4 becomes, "Like-minded individuals would endeavor to carry on the mission if there was a loss of key leaders in rapid succession during the April 2006 to April 2007 timeframe."

Rule 10: For each event, indicate if it is a policy or decision recommendation.

Causal Proguesors

A policy or decision event is a recommendation of something the presumed consumer of the document should do. In this case the document was a National Intelligence Estimate and it appears to recommend that US policy makers adopt a course of action of "Exposing the religious and political straightjacket that is ... "

Rule 11: For each event, indicate if it is a hypothetical event.

Causal Precursors

A hypothetical event is any event, other than policy events, which the document introduces as a purely hypothetical possibility. In this case the statement about the loss of key leaders seems to describe a hypothetical scenario rather than any kind of forecast.

The determination of whether an event is "purely hypothetical" is a judgment call. Don't agonize over this. The determination that something is hypothetical will not significantly affect accuracy analysis.

FYI: How we use this partitioning

Study Forecast Accuracy

• Study Accuracy of causal connections described in the document

Study forecast accuracy

- Purpose
 - Measure calibration of forecasts expressed with varying degrees of certainty

• Method:

- List all future events for which there are no hypothetical, policy or definitional precursors
- People read the forecast document and then assign *inferred probabilities* to each listed future event
- SMEs, who do not see the forecast document, retrospectively judge whether each event occurred
- Calibration (and other standard measures) applied.

Study accuracy of causal model

• Purpose:

• Measure degree to which a claim that forecast documents helps policy makers understand the situation (e.g. key drivers) is true.

• Method:

- Examine each causal connection $(A \rightarrow B)$
- If A and B occur, label it accurate
- If A occurs and B does not, label it inaccurate
- If A does not occur and B occurs, label it irrelevant
- If neither occurs, then label it accurate.
